Spotlight On: Ministry and Clearness Committee

The "M&C" serves to do what the name of the Committee implies: minister to the members and attenders of the Meeting, and to help find clarity in spiritual matters for the Meeting as a whole or for individual Friends.

The Committee most typically serves the following functions for our Meeting:

- •Nominating members and attenders to serve on various committees at the Meeting,
- Meeting with attenders who wish to become full members of the Meeting,
- •Working with couples who wish to be married or joined together in the manner of Quakers before the whole Meeting,
- Responding to any specific problem or concern within the Meeting itself in order to work towards restoring unity in a peaceful way, and
- Ministering to those in the Meeting in need of spiritual support or comfort as they deal with personal issues like the loss of a loved one or health problems

M&C is available to serve any member or attender of the Meeting who asks for our help on a specific concern. The idea is to provide compassionate yet objective outside perspective in discerning what would be the best way for the Friend to deal whatever is going on, ultimately helping them detach enough from their own situation to be able to get a

clear sense of God's will. M&C members don't tell anybody what to do but can serve as a great sounding board and mirror to help a Friend move forward through a challenging life.

The current sense of M&C is that we are now in a healthy state of functioning with thriving attendance and free of any serious problems that impair Meeting. With this strong foundation, we want the Meeting as a whole to think more in terms of aspirations and growth of ourselves as a spiritual community. We invite members and attenders to let M&C know how they think we could serve the Meeting best in this capacity of developing a more thriving and spiritually enlightened community (e.g. adult religious education on Quaker process and teaching, monthly workshops, special silent worship gatherings, etc)

M&C is currently served by a small group of five veteran Meeting members who are familiar with Quaker process and SEYM faith and practice traditions:

Financial Realities

Ours is the Religious Society of Friends, not the Business Society of Friends. However, to be effective members of our Meeting we must be familiar with certain business matters. This include how the Meeting pays its bills.

Quakers of Orlando is fortunate to own our Meeting house and the cottage property debt free. We also have a modest endowment, which is a source of funds for the maintenance of our property.

Our Quaker activities are the financial responsibility of our Members and Attenders (M&A). These Quaker activities include: First Day School, the library, Committee expenses, outreach, hospitality, office supplies, donations,

and Southeastern Yearly Meeting Apportionment (our share of our regional organization expense).

The total budgeted expense of our Quaker activities (excluding property maintenance) is \$10,450 per year. We have approximately 40 active Members and Attenders. Dividing our Quaker activity expense by 40 M&A results in an annual \$261.25 Quaker activity expense per M&A, or \$5.02 per week.

Some of our members and attenders are unable to pay this \$5.02 amount. Others can and do pay more to cover this total budgeted expense.

Many expense issues are brought forward at Meeting for Business, which allows everyone to stay informed.

For those willing to delve into history, "The Story of Quakerism" by Elfrida Vipont, Friends United Press, 1977, is in our HST (history) section. This book shows signs of being loved like a velveteen rabbit and is now held together by a rubber band. It gives a fascinating account of Quaker history from the beginnings to the 1950s.

Who We Are: FCNL

The Friends Committee on National Legislation (FCNL) fields the largest team of registered peace lobbyists in Washington, DC. Founded in 1943 by members of the Religious Society of Friends (Quakers), FCNL staff and volunteers work with a nationwide network of tens of thousands of people from many different races, religions, and cultures to advocate social and economic justice, peace, and good government. FCNL is nonpartisan.

FCNL is also the oldest registered ecumenical lobby in Washington, DC. The organization's legislative priorities and policies are set by a General Committee made up of some 220 Quakers from around the country. FCNL's multi-issue advocacy connects historic Quaker testimonies on peace, equality, simplicity, and truth with peace and social justice issues which the United States government is or should be addressing.
