Care and Community Committee Description

Approved by Meeting for 2019 - 2021

Care & Community: Care & Community is concerned with the care and welfare of individual meeting members and attenders. It treats all issues that come before it with the highest level of confidentiality and respect. The committee provides or facilitates clearness committees for membership, personal discernment and marriage. A clearness committee for marriage may also serve as the couple's arrangements committee. Care & Community awards scholarship funds that are within the purview of the meeting. The committee may refer individuals to resources within or outside of meeting for counseling, social services and other assistance. The committee may provide practical support for members and attenders needing emergency material or financial assistance. It is responsible for the meeting's homeless ministry. Care & Community stays in touch with absent members and long-time attenders; it determines whether a visit to the individual or transportation to meeting is desired and will assist when possible. The committee may appoint one of its members to assist the membership recorder when needed. It gives care and aid with needed arrangements at the time of death. It works with the worship & ministry committee to select members for the naming committee, and to discern the membership of long-absent Friends.

Minutes:

We gathered with quiet and agreed to move forward with the agenda. We reviewed recent and current concerns of the Meeting as listed on the agenda and reflected in the queries shown on the agenda.

Minerva is led to work on the child and family detention concern. She is attending a webinar on Saturday with the ACLU. Children are being held or sent back to Mexico on the rationale of COVID, including unaccompanied young teens. Minerva will report back and let us know what support is needed.

Greg is representing Habitat on a newly formed evictions and foreclosures workgroup. He will report back on this. The workgroup includes judges, realtors, not-for-profits, and more. It will meet weekly. They began by evaluating the situation. The workgroup anticipates a crisis is coming, probably early next year. Regarding the Sadowski funds for affordable housing, there will be a staffing coalition meeting next week to form a strategic plan on this critical budget line item.

Sharon reported on a TED Talk by Bono of U2 on "The Good News About Poverty" and her understanding that he is able to be so positive because of what he's already been able to accomplish. She is led to research more about Bono's "One Campaign." This campaign addresses poverty in the "big picture" with the goal of erasing poverty by 2030. Sharon is going to continue to research and report back on this.

Jerry suggested a Conversation to Explore in which Friends of color could openly and safely express thoughts on systemic racism and the Black Lives Matter movement. Minerva has Conversation to Explore committed through the winter Holidays. Minerva will work on this

possibility. Greg suggested an outside facilitator/speaker, too. Minerva recognized that more than one Conversation to Explore is possible in relation to this concern.

Liz reviewed a number of resources for responding to our concerns both within the Meeting, within SEYM, within the wider Quaker world and beyond Quakerism.

Friends present were in unity that Clerk bring forward the St. Petersburg Monthly Meeting Statement of Support for the Black Lives Matter Movement for consideration at Meeting for Worship with Attention to Business.

Minerva and Greg expressed an interest in attending the Peace Breakfast with Liz and she will share the invitation through Quaker Notes in case other Friends would also like to register.

The next meeting of Peace and Social Concerns will be 10/8/2020 at 6:00 p.m.

- 1. We gathered with a few minutes of quiet just after 1:00 p.m.
- 2. We shared a brief check-in time with each other.
- 3. The agenda was accepted as proposed. It was noted that agenda item #11 would provide for discussion of a question about the Meeting's newsletter.
- 4. Liz agreed to serve as Recording Clerk for this session.
- 5. We reviewed and accepted the minutes from 8/4/2020 with thanks to Minerva.
- 6. We discussed relief for Meeting Clerk from the task of monitoring and controlling the waiting room for all Meetings for Worship. It was agreed that the current system is working acceptably and that Meeting Clerk can call on alternate hosts including Stephanie, Kody, Greg, and Gary, when relief is needed.
- 7. In an update on "Movie Night," Kody reported that he has conducted Zoom host training sessions with Kasper and a schedule of movies to continue through June/Sixth Month 2021. This information has already been sent to the SEYM Administrative Secretary and Kasper is ready to submit timely Movie Night announcements to Gary for Quaker Notes.
- 8. Minerva reported on her research regarding plans for Winter Interim Business Meeting, Michener Lecture and related events for the weekend of 1/15/2021 to 1/17/2021. There is a high probability that the Michener Lecture will be on Zoom and lecturer Petra Doan is willing and able to use this format. Worship and Ministry committee members were asked to respond to the question: "If SEYM wished to hold Executive Committee Meeting and Winter Interim Business Meeting in person, would Orlando Monthly Meeting be comfortable to host those meetings in person?" Committee members reflected and considered concerns and options. Committee members agreed on the following minute. This minute will be presented at OMM Meeting for Worship with Attention to Business on 9/13/2020. It was noted that SEYM Executive Committee will meet at Fall Interim Business Meeting on 10/10/2020 to make decisions about this matter.

9. In an update on Meeting's needs, as seen by the Meeting Clerk, Liz reported that seven people attended the first Zoom Conversation to Explore on 8/27/2020 and that the conversation ran the full hour provided and the topic of "Prayer" appeared to be

meaningful for participants. Thanks to Zoom, participants were able to attend from a nursing home, from New Mexico, and while having a very young child get ready for bed. Statement of Support for the Black Lives Matter Movement

We support the Black Lives Matter movement. We grieve over the loss of Black lives and over the trauma and tragedy the Black community has endured at the hands of our police and our criminal justice system. We support the demands for eliminating racial bias and the excessive use of force in policing, which have so disproportionately targeted Black people.

We unite with those calling for a radical re-imagining of how policing is defined, funded, and implemented in the larger context of community safety and services. Where this approach has been adopted, the results have been lower crime, safer communities, more trust between police and the public, and a less burdened and less traumatized police force.

We unite with those who protest peacefully; who engage in non-violent action and civil disobedience to challenge systemic racism and the killing and harassment of Black men and women on the streets of our cities. While we understand the anger that leads some to react to oppression with violence, as Quakers we lift up non-violence as the way to bring about real and lasting change. The transformation we seek begins both in ourselves and in how we engage in the struggle for justice.

Those of us who enjoy the benefits of a good education, health care, jobs, and safety in our homes and streets must wake up to the ways that Black people are deprived of these basic rights, and speak up. We must wake up to how Black people are disproportionately incarcerated and disenfranchised. And when we are awakened, WE MUST SPEAK OUT! These injustices and inequities cannot be allowed to continue.

As Quakers, we unite with Martin Luther King Jr.'s vision of the Beloved Community. It is our experience that as Spirit speaks in our hearts, we are called to create communities of equity, reconciliation, inclusion and justice --- where every person is recognized as a beloved child of God.

Program for Social and Community Giving

Preface: Orlando Monthly meeting has a significant endowment to support the operations and work of the meeting.

Orlando Monthly Meeting of the Religious Society of Friends (OMM) has a history of making gifts to not for profit organizations to support the work that those organizations do that is consistent with Quaker values and testimonies.

OMM has charged the Social and Community Giving Committee with suggesting organizations and gift amounts to OMM for their review and approval.

This document provides general guidance to the Social and Community Giving Committee on the principles and process to follow in making those recommendations.

Principles

Friends' funds are to be used with integrity and in a manner consistent with Friends' Testimonies.

- Funds will be used in a manner consistent with the laws regulating 501(c)3 organizations
- Funds will not be used for the direct personal benefit of members or attenders of OMM
- OMM will not distribute funds in the form of donations or grants unless there is unity on the donation expressed at a meeting for worship with attention to business.
- OMM does not have the expertise, nor the personnel to function as auditors or advisors to the organizations that we support.
- Accountability of supported organizations is important, but the mechanisms to ensure accountability should not create undue burden on either OMM or the supported organization and should be commensurate with the level of support given.

Process

OMM shall consider two types of gifts when supporting organizations

- Donations gifts of less than \$10,000
- Grants gifts of \$10,000 or more.

When recommending a *donation* the Social and Community Giving Committee will at a minimum verify:

- The supported organization is a 501(c)3 in good standing
- The program being supported is consistent with Quaker testimonies.

When recommending a *grant* the Social and Community Giving Committee will at a minimum:

- Verify the supported organization is a 501(c)3 organization in good standing
- Verify the program being supported is consistent with Quaker Testimonies
- Review the financial statements of the supported organization for the last three years (IRS forms 990 and audited financial statements (if available).
- Review the supported organization's ratings on Guidestar and Charity Navigator
- Perform an internet news search on the supported organization

- Request a description from the supported organization of how they plan to use the funds.
- At the end of the grant period request a description of how the grant funds were used.

The Social and Community Giving Committee will ensure that in any given year a substantial percentage of the gifts recommended will be to support local community based organizations and that a substantial percentage of the gifts recommended will be to support national and international Quaker related organizations.

The Social and Community Giving Committee will work within the budget determined by OMM for donations and grants and will establish a meeting schedule that ensures that they can make recommendations for support no later than the November meeting for business.

Treasurer: Receives and disburses funds as directed by the Meeting, keeps financial records, coordinates with accountant or trustees to review/audit books annually. Proposes the annual budget, coordinating with Trustees. Picks up donations from donation box and makes deposits into Meeting accounts. Ensures sales tax-exemption is up to date. Oversees petty cash available to Property Caretaker. Serves as an Officer/Director of the OMM corporation. Reviews Insurance policies & keeps them up to date. Serves as an ex officio member of the finance committee.
