Meeting Clerk Stephanie Preston invited Friends to gather in worship.

The Agenda is displayed on a whiteboard for members to view.

Clerk's chosen quotation for the Ninth Month:

Treasurer's Report – Treasurer Tom Gottshalk: Tom explained expenses are well within the budget over the first half of the year. Orlando Meeting's next SEYM apportionment was noted. This year's allocation has been paid. Individual contributions are lagging behind. Efforts are underway to increase giving before year's end. [The Treasurer's report is attached.]

Property Committee - Ray Jenkins, Committee Clerk: Ray distributed the proposed "Facilities Use Policy" and "Facility Use Contract" required for groups requesting use of the meetinghouse and the cottage. Ray reviewed changes and made points of emphasis. Friends discussed several parts of the use policy. One provision addressing "not for profit" groups was reconsidered. There was a discussion of an applicant's "proof of insurance" and how requiring it might limit utilization of our facilities. A provision prohibiting drug and alcohol use was added.

09-2016.01 Friends approve the Facilities Use Policy, as amended. [The document is attached.]

The Property Committee will bring forward requests falling outside of the approved guidelines to the Meeting Clerk or Meeting for Business.

The "Facilities Use Contract" was reviewed. There were no suggested changes.

09-2016.02 Friends approve the Facilities Use Contract as presented. [The document is attached.]

Worship and Ministry Committee Report - Vicki Carlie, Clerk: The Committee brought forth a minute about "... building Community and celebrating life in the spirit." The committee recommends the meeting's "Friday Night Friends" gathering evolve to become "Fifth Sunday Friends."

09-2016.03 Friends adopt the following minute from the Worship and Ministry Report, Ninth Month 2016:

W&M affirms how valuable Friday Night Friends has been to the Life of the Meeting. We have enjoyed gathering once a month to share home cooked meals, stories, laughter, and friendship --- building Community and celebrating life in the spirit.

We thank Stephanie Preston for following her leading to start Friday Night Friends. Worship & Ministry, in discernment with Stephanie, recommends that Friday Night Friends evolve to be Fifth Sunday Friends--- that Meeting would begin holding potluck lunches on the 5th Sundays in a month in place of having a Conversation to Explore that day.

With only 4 Fifth Sundays in a year, this would be a regular event, but not be frequent enough to be burdensome. Friends need the extra free time to get to know each other better, enjoy each others company and have space as a community to see where Spirit leads.

"Sustainability Testimony" - Worship & Ministry recommends that, if SEYM does not already have a minute naming Sustainability as one of our key testimonies along with SPICE, that OMM consider adopting a minute recognizing that Sustainability is a key testimony, and forward it to SEYM/FIBM with the request that SEYM considers a similar minute, and consider adding a section on Sustainability to our Faith & Practice. The Committee's rationale is attached.

Friends undertook a discussion about various aspects of the proposal. A focal point was a comparison of "sustainability" and "stewardship." There were differing understandings of these concepts and varying definitions. It was agreed the proposed minute needs further discernment.

Grants Committee Report - Kate Joseph, a committee member, presented a list of grants recommended for adoption. There were explanations of particular awards. The complete list is attached. The committee's report provides the recipients' websites for Friends to visit. [Note: the web addresses may link by clicking directly from the list. If not, the address can be copied and pasted in a browser.

9-2016.04 Friends approve the distribution of grant funds as recommended by the Grants Committee, as amended. [The award list is attached.] This distribution comes from Line Item #8600 of the budget.

Care and Community Report - Committee Clerk Minerva Glidden: Friend Minerva presented for consideration a revised proposal of the "Agreement of Behavior/s At Meeting" prepared by the Care and Community Committee.

After Spirit had led reflection and discussion, Friends concluded the "Agreement" needs further revision. Among the concerns were the priority of the provisions, the wording and meaning of specific provisions, and experiences members have faced or feel a need to address. Much of the discussion considered lavatory usage and disruptions of the meeting for worship. Members are concerned about perceived threatening and any illegal activity. Also considered were the manner for implementing the provisions and consequences of violations.

The Clerk said Friends had reached some clarity and agreement, but the proposal was not ready for approval. Friends concurred. The "Agreement of Behavior/s At Meeting" is

held over for October's business meeting. For continued discernment, the report appears as an attachment to these minutes.

The Clerk asked for new items for the October agenda. The meeting concluded in silent worship at 1:45 pm.

- 8. Quaker functions take precedence in scheduling.

Minute Recognizing Sustainability as a central Quaker Testimony

Orlando Monthly Meeting recognizes the practice of Sustainability as a testimony to the Spirit, one that has become enduring and central to our faith, as are the Quaker testimonies of Simplicity, Peace, Integrity, Community and Equality.

For many decades, as we have seen humanity's impacts on the environment cause extinction of species and destruction of ecosystems, Friends have been concerned with protecting the environment, carrying forward the testimony of Stewardship and care for the earth. More recently, many Friends Meetings and organizations have taken up the testimony of Sustainability, witnessing to the urgent need to put sustainable practices and ways of living in place to protect the earth and mitigate the threat of climate change.

We recognize that the well-being of the earth is a fundamental spiritual concern. From the beginning, it was through the wonders of nature that people saw God. How we treat the earth and its creatures is a basic part of our relationship with God. Our planet as a whole, not just the small parts of it in our immediate custody, requires our responsible attention.

PROPOSED AGREEMENT OF BEHAVIOR/S AT MEETING

- (1) There is to be no stealing of personal items, Meeting House's stock and/or supplies
- (2) There is to be no solicitation of any kind
- (3) We ask that if the bathroom is used during Meeting for Worship that it be no more than once and for a short period of time. There is to be no shaving, bathing or grooming of any kind.
- (4) Everyone should be fully clothed when they are on Meeting House property, both indoors or out
- (5) We ask that people accept no, as an answer. There is be be no badgering, pleading or threatening either real or implied.

The group decided that for the health and wellbeing of the Meeting and with tenderness to all, the following responses / actions are in order.

- (1) Anyone who is observed disregarding these agreements of behavior and after verification the offending individual will be taken aside and tenderly made aware, of these expectations, either by Clerk or by a member of Care and Community. Anyone who personally experiences a breech of these expectations can speak with Clerk or with a member of Care and Community and the offending individual will be spoken to and made aware of expected behaviors.
- (2) If the offending behavior is observed and verified a for a second time, that individual will be asked to leave immediately and told that they will be welcomed back the following week.
- (3) If the offending behavior is observed and verified for a second time, that individual will be asked to leave and told they are not to return for 4 weeks.
- (4) The third time that the offending behavior is observed and verified that individual will be asked to not to return for 6 months (?).
